Just before Christmas I was sent a complimentary copy of the book "Mines a pint-Whats yours?" by Bill Tidy and published by Pearl Books. The book is subtitled "The KegBuster Story" and it consists of a collection of about 60 KegBuster cartoons that have appeared in previous editions of Whats Brewing.

Centred on the exploits of the legendary KegBuster, the drinkers champion, its a rip-roaring and irreverent poke at tasteless, fizzy keg beers and at the big brewery combines in general. Its also a celebration of the year-round pleasures of pubs, good beer and good company. This is what the promotion material says, by the way.

In fact the content of the book is very amusing and it makes for a very pleasant 30 minutes reading which, unfortunately, is the books main drawback. It is far too short and as a result not the best value for money at £1.95 a copy. However no doubt some people will be taken in, notably those who feel at a loss without every possible item of CAMRA material in their possession.

Then again is £1.95 a high price to pay for 30 minutes of escapism in the cold, miserable and cynical world of today?

BULL ENRAGES A BREWERY

Paines, the St. Neots brewery, is being taken to court by Allied Breweries over the use of the John Bull trademark. Paines use the name for its beer and wine making kits. Allied Breweries recently launched a big promotion of its John Bull bitter. Allied Breweries is seeking a High Court injunction, with damages, against Paines using the name. Allied alleges Paines is in breach of a 1936 agreement under which, it claims, Paines would drop the trademark. But Paines, who, also used to brew a beer called John Bull bitter, dispute the claim.
