# TOLLY TAKE OVER JAMES PAINE



As has been widely reported in the local press, Tolly Cobbold of Ipswich have taken a majority shareholding in our local James Paine Brewery. The news came as no surprise to the local CAMRA Branch, having been prophesied in previous newsletters. Brewing has now ceased at St. Neots - with unconfirmed rumours flying about for months. The James Paine range of draught beers - Mild, XXX Bitter and EG are now being brewed at Ipswich. We are told that the beers are being 'matched' (though flavours inevitably change with the brewing location) but with modifica-

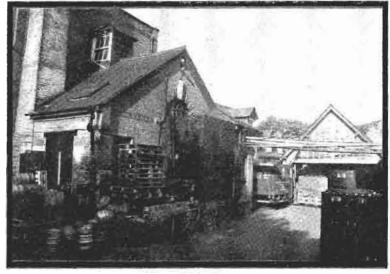
tions on existing brews rather than original

recipes.

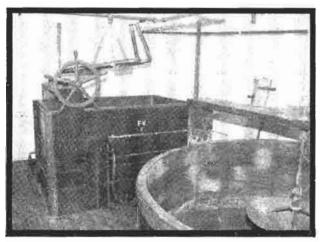
It is a sad day for St.Neots that we no longer have our own brewery in the town but the complete lack of public re-action to the closure speaks for itself on the inconsistent beer quality over the last few years. It remains to be seen whether Tolly need the three James Paine beers in their portfolio when they have four cask beers of their own to market, five if Old Strong(their winter warmer) makes a reappearance. So with the remaining six pubs staying under the James Paine banner, selling beers under the two brewery names, then local drinkers can expect an upsurge in the consistency of quality.

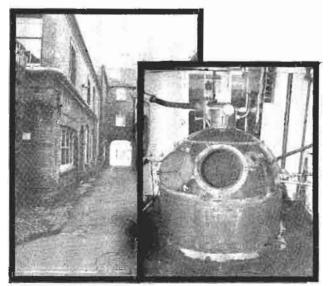






The takeover news came as inevitable to the local CAMRA branch members, who had expressed exactly these fears to brewery representatives over the years and had them vehemently denied. James Paine had been selling off their pubs for several years since the consortium had taken the brewery over and were privately accused of asset stripping by the local CAMRA branch. The tied estate now numbers but six pubs - when it was once over 20, the income received not appearing to be spent on major refurbishment of the brewery site - but enough to maintain it until selling date. The tied arrangement in pubs sold as 'freehouses' are now expiring and therefore local outlets receding. A reciprocal arrangement with Tolly was undertaken with Tolly beers appearing in our local James Paine houses and Paines beers appearing in Tolly pubs in Cambridge and elsewhere.CAMRA has previously expressed fears in newsletters and to the Brewery that the pubs were being hived off to be followed by the brewery itself,

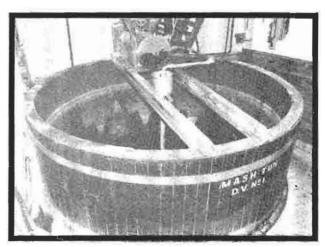






which was of course denied.

The next question is what is going to happen to the site? Plans have been submitted for the redevelopment as shops and flats. This causes grave concern as the facade is a Grade II listed building, the main interior brewhouse walls are also listed and the building as a whole is a fine example of a Victorian Tower Brewery and should be preserved at all costs. Bearing in mind the Brewerys 150 year association with the town surely the developers can come up with a scheme that will keep the external fabric of the building intact. The site only has its high commercial property value if planning permission is granted. Therefore, perhaps the site could be utilised as a tourist attraction as a brewery museum/town museum for which there is a local need. Also a pub could be incorporated - not we hasten to add on the lines of the Cross Keys development which did nothing to retain its previous character. Another alternative would be to sell the site as a brewery to a small brewery, but that of course would never happen in these days of fierce competition.



# What's happening at Watneys?

The recent take-over of Rutland Brewers Ruddles by Grand Metropolitan parent company of Watneys has led to their revered 'County' becoming much more widely available in the St. Neots CAMRA branch area, through Manns and Chef and Brewer houses. Both The Market Inn and The Falcon in Huntingdon, The Harrier in Brampton and The Cock at Hemingford now take the beer. Also, freehouses seem to be stocking County more widely now, recent sightings including The Ferryboat, Holywell and The Jolly Abbot, Abbotsley. This is all to the good for the confirmed County fan, but, nationally (almost national in England at least) the now wide availability of County seems to be pushing other Watney Group real ales off the bar, just in fact as CAMRA said it would if Watneys and Ruddles come under the same ownership.

Locally names lost over the small number of years since

Watneys re-introduced real ale have included Stag, Manns IPA,

Manns Traditional Bitter (no outlets known by this author) and the excellent Ushers Founders (itself and its brewery, Ushers, now under threat from Watneys rationalisation) Indeed it would seem that, in the provinces at least, Grand Metropolitans brewing arm is intent on having just two real ales, County and Websters Yorkshire Bitter (the latter sold in keg form in many outlets), so local fans of Wilsons\*\* look out! County fans may ponder all this as they sip their pints and beer drinkers generally reflect as yet another CAMRA prediction comes true.
